All of the shares reported as disposed of in this Form 4 were relinquished by the Reporting Person and cancelled by the Issuer in exchange for the Issuer's agreement to pay federal and state tax withholding obligations of the Reporting Person resulting from the vesting of restricted stock units. The Reporting Person did not sell or otherwise dispose of any of the shares reported on this Form 4 for any reason other than to cover required taxes.
- (The option shall vest over a four year period as follows: 25% of the shares shall vest on February 11, 2017, and 1/48th of the shares shall vest monthly thereafter, subject to the Reporting Person's continuous service.
