- (1) Pursuant to the Contribution Agreement by and among the Issuer, Susser Petroleum Partners GP LLC, Susser Holdings Corporation ("SHC"), Susser Holdings, L.L.C., Stripes LLC and Susser Petroleum Company LLC, dated September 25, 2012, Stripes LLC received 14,436 Common Units and 5,469,718 Subordinated Units and Stripes No. 1009 LLC received 5,469,718 in connection with the closing of the Issuer's initial public offering. SHC may be deemed to share beneficial ownership of Stripes LLC's and Stripes No. 1009 LLC's interests in the Issuer through SHC's ability to control Stripes LLC and Stripes No. 1009 LLC.
- (2) The Subordinated Units will convert into Common Units on a one-for-one basis at the end of the Subordination Period as described in the Issuer's Registration Statement on Form S-1 (File No. 333-182276).
