Explanation of Responses:

- (1) On March 31, 2015, each holder of a unit of Desert Newco, LLC received a number of shares of Class B Common Stock of GoDaddy Inc. Inc. (the "Company") equal to the number of units held by such person. Shares of Class B Common Stock do not have economic

rights.

- (2) Represents restricted stock units that were fully vested on February 1, 2015. Following the closing of the Company's IPO, pursuant to the terms of and subject to the limitations and restrictions set forth in an exchange agreement, units of Desert Newco, LLC are exchangeable for shares of Class A Common Stock on a one-for-one basis. Upon any such exchange for Class A Common Stock, the corresponding shares of Class B Common Stock then owned by such holder will be cancelled.
- (3) 20% of the shares underlying the option vests on November 10, 2015 and the remaining shares shall vest in 4 equal annual installments thereafter.
